Why are you receiving this request? The U. S. What are the consequences? We MUST receive these documents in order to confirm the accuracy of information reported on your FAFSA. We cannot make any financial aid awards until this process is complete. Any financial aid award that was previously awarded will be placed on hold until this process is complete. If your financial aid award changes as a result of this review, we will notify you of the changes and any resolution required.
