The information requested on this form is needed to process your application for financial aid for the 2025-2026 academic year. This form must be completed by an authorized individual who can confirm your living situation and independent status. On the 2025-2026 Free Application for Federal Student Aid (FAFSA), you indicated you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless at any time on or after July 1, 2024.

- “Homeless” means lacking fixed, regular, and adequate housing which includes living in shelters, motels, or cars, or temporarily living with other people because you had nowhere else to go. Also, if you are living in any of these situations and fleeing an abusive parent you may be considered homeless even if your parent would otherwise provide support and a place to live.
- “Unaccompanied” means you are not living in the physical custody of your parent or guardian.
- “Youth” means you are under 21 years of age, or you were still enrolled in high school as of the day you signed your FAFSA. Students who don’t meet the definition of “youth” because they are older than 21 (and not yet 24) may qualify for a homeless youth determination given adequate documentation is provided.

If, in a prior academic year, you were declared an unaccompanied youth who was homeless or self-supporting and at risk of being homeless based on the criteria listed above, and, you submitted supporting documentation to the Financial Aid Office at MACC, you do not need to complete this form.
