RESPONSIBILITIES

The recipient agrees to:

1. Complete all HighScope Curriculum training.
2. Participate in regular on-site coaching with a HighScope Curriculum Coach.
3. Be filmed working in the classroom at the start and again at the completion of the training.
4. Complete screenings on the children in classroom once per year using the Screening Hub online.
5. Attend Early Childhood Positive Behavior Support (EC-PBS) training and receive on-site coaching with an EC-PBS coach.
